# **SCHOOL ASBESTOS TRAINING SERIES**

### Is your asbestos training up to date?

## The University of North Dakota's Environmental Training Institute is holding a series of asbestos training classes to help North Dakota Schools maintain compliance with AHERA regulations.

According to the EPA regulations governing schools, all school custodial and maintenance staff who work in buildings where asbestos is present should complete at least a 2 hour awareness training session. Individuals who conduct any activities that may result in the disturbance of asbestos-containing building material (ACBM) must receive an additional 14 hours of Special O&M Training.

#### ASBESTOS AWARENESS TRAINING: 2 hour (\$135.00)

This Asbestos Awareness training course provides attendees with general overview of asbestos including how to identify it, the health effects of exposure and how to prevent it, and regulatory requirements This class meets both OSHA and EPA's training requirements for maintenance and custodial staff working in buildings where asbestos is present. Both the EPA and OSHA recommend this training be completed on an annual basis.

#### ASBESTOS OPERATIONS & MAINTENANCE (O&M/CLASS III): 16 hour (\$425.00)

This two-day asbestos training course educates maintenance and custodial workers involved in general maintenance where asbestos-containing material (ACM) is likely to be disturbed. This course includes hands-on exercises and demonstrations. Topics

covered: Identifying asbestos, developing an O&M program, health effects, personal protective equipment, control methods and work practices, maintenance related removal, and regulations. This training meets OSHA Class III and EPA 16-hour training requirements.

#### ASBESTOS OPERATIONS & MAINTENANCE ANNUAL REFRESHER): 2 hour (\$135.00)

This two-hour refresher class provides attendees with a review of asbestos topics associated with OSHA Class III and EPA Operations and Maintenance work.

#### ASBESTOS DESIGNATED PERSON TRAINING: 8 hour (\$265.00)

This asbestos training course provides the required training under AHERA for Local Education Agencies (LEA's) to comply with the Asbestos Containing Materials in schools rule. Topics covered: Detection, Identification and assessment of asbestos-containing material, Health effects, Controlling asbestos-containing building material, Asbestos management plans; and Federal and state regulations.
